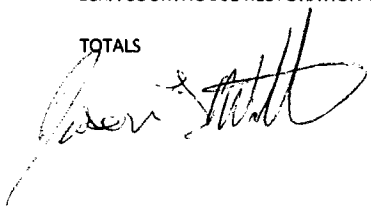
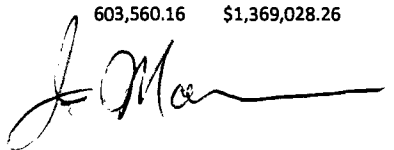



**IN THE MATTER OF THE MONTHLY REPORT OF

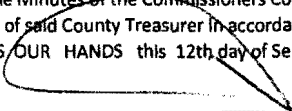

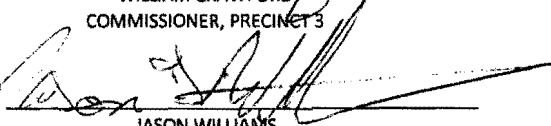
